At this time we will open the Bond Issuance Notification Act required hearing to receive any comments relative to the District's proposal to sell \$750,000 in General Obligation Limited Tax Park Bonds.

The proposed bonds are to be issued for the payment of land condemned or purchased for parks, for the building, maintaining, improving and protecting of the same and the existing land and facilities of the District and for the payment of the expenses incident thereto.

Each year the Board considers the ordinances for tax abatements on the Pinecrest Clubhouse and REC Center. The amounts in question are approximately \$241,784 for the Pinecrest Clubhouse and \$221,663 for the REC Center.

Relay for Life

The American Cancer Society has requested to hold the 2017 Relay for Life event on Saturday, June 3, 2017 at Deicke Park. They will move the event indoors to the gymnasium in case of inclement weather. The Park District charges a \$300 fee for staff time and use of tables and chairs and electrical. We receive positive feedback on the facilities and it brings new people to the Huntley Park District.

A motion to approve the American Cancer Society's Relay for Life event as presented was made by Commissioner Wold and seconded by Commissioner Blasky. All ayes. Motion carried.

Cancer Kiss My Cooley 5K

Cancer Kiss My Cooley has requested to host a 5K Run/Walk on Sunday, May 14, 2017. Set up and race will take place between the hours of 5:30 AM and 11:00 AM. They will be using the Betsey Warrington shelter and trails in Deicke and Betsey Warrington Parks. The current 5K route will be revised due to the Parks Facility project. Cancer Kiss My Cooley is an organization that raises funds for brain cancer research. The Park District will waive the shelter rental fees for this event as in the past. Requesting variance of the following ordinances: Section I-firearms – starting gun, VI – Advertising, VIII – Vehicles on Park District Property, XIV- Use of Outside of Park hours.

A motion to approve the Cancer Kiss My Cooley 5K Run as presented was made by Commissioner Wold and seconded by Commissioner Awe. All ayes. Motion carried.
