2015 Budget and Appropriation Ordinance

Miraculous Multiples Mothers of Twins Club Request

The Board reviewed The Miraculous Multiples Mothers of Twins Club variances of ordinances request. The Miraculous Multiples Mothers of Twins Club has rented the REC Center Gym in the past. They have been very good renters and are providing a great service to the community. The rental is tentatively scheduled for April 10 & 11, 2015.

A motion to approve the Variances of Ordinances for offering articles for sale (Ordinance Section V) and Advertising (Ordinance Section VI) for the Miraculous Multiples Mothers of Twins Club as presented was made by Commissioner Wold and seconded by Commissioner LaFleur. All ayes. Motion carried.

Fireworks Parks Use

The Village of Huntley approached the Huntley Park District requesting the use of Deicke and Warrington Parks for a public gathering place to view the annual 4th of July fireworks. The Mayor and Village Manager met with the Parks Committee (Nepermann/Blasky) and the Executive Director to discuss this request. Paul Ostrander, Parks Maintenance Director and Nancy Sprouse, Facility Reservations Manager has reviewed this information. The Parks Committee and staff feel that this event is feasible and beneficial to the community.

Consensus for approval: 5 - 0. Details to consider approval will be presented at the April 22, 2015 Board meeting.

Jacobsen Mower Disposal

Paul Ostrander is seeking permission to place the HR9016 16' Jacobsen mower out for online auction or trade-in, whichever yields the highest financial return. A new mower for purchase is in the budget this year. Paul thought it best to sell the mower due to its age (2005) and hours (6600). A bottom limit of \$6,500 has been set as that was the trade-in offer. On line comparable machines have been listed from \$8,000 - \$13,000. If the auction does not meet the bottom line, Paul will trade in the mower.

A motion to approve the surplus equipment resolution as presented was made by Commissioner Wold and seconded by Commissioner LaFleur.

All ayes. Motion carried.

Surplus Fitness Equipment

With the addition of the new Cybex Total Access strength and cardiovascular fitness equipment line, there will be 13 pieces of strength and cardiovascular equipment that will need to be removed from the Fitness Center floor. This excess equipment can be stripped and scrapped by the Huntley Park District. Gary Zierer mentioned that the weight plates from the strength equipment could potentially be used for some projects.

A motion to approve the fitness surplus equipment resolution as presented was made by Commissioner LaFleur and seconded by Commissioner Wold.
