Parks: In addition to Paul Ostrander's submitted report, Commissioner Nepermann provided positive feedback on the Christmas Tree Drop Off. Commissioner Wold complimented on the recent creek cleanup.

Recreation: In addition to Scott Crowe's submitted report, Commissioner Blasky asked for an update on the Youth Recreation staffing situation and how the staff is currently handling programming. Scott replied that the team has done a great job, creating new, sustainable programs. Overall, it has been a great team effort.

Commissioner Blasky questioned how Remote Learning Camp would work with kids returning to school. Scott explained that even with the new hybrid school schedule starting, the program is still very busy with the groups that are currently attending. The recreation team is working ahead towards summer programming. Commissioner Nepermann asked how the universal ID cards transition would affect operations. Scott answered that this will streamline our membership services across the park district, and it will be more cost-effective.
