Motion to approve Ordinance 2025-01 providing for the issue of not to exceed \$14,200,000 General Obligation Park Bonds, Series 2025A, of the Huntley Park District, McHenry and Kane Counties, Illinois, for the purpose of paying the costs of those capital projects set forth in the ballot proposition approved by the voters of the District at the November 5, 2024, general election, providing for the levy of a direct annual tax sufficient to pay the principal and interest on said bonds, and authorizing the sale of said bonds to Stifel, Nicolaus & Company, Incorporated was made by Commissioner Kellas and seconded by Commissioner Nepermann.

Approve Parameters Ordinance for Series 2025B General Obligation Park Bonds (Alternative Revenue Source)

A motion to approve Ordinance 2025-02 providing for the issue of not to exceed \$2,150,000 General Obligation Park Bonds (Alternate Revenue Source), Series 2025B, of the Huntley Park District, McHenry and Kane Counties, Illinois, for the payment of land condemned or purchased for parks, for the building, maintaining, improving and protecting of the same and the existing land and facilities of the District, for the refunding of certain outstanding alternate bonds and debt certificates of the District,

and for the paying of expenses incident thereto, providing for the pledge of certain revenues to the payment of principal and interest on said bonds, providing for the levy of a direct annual tax sufficient to pay such principal and interest if the pledged revenues are insufficient to make such payment and authorizing the sale of said bonds to Stifel, Nicolaus & Company, Incorporated. was made by Commissioner Awe and seconded by Commissioner Kellas.
